Compass Group provides 12 months of continuous coverage for all Associates that measure full time. Educational Team Member Associates are not scheduled to work 52 weeks in a year and therefore, the deductions must be taken over a shorter period of time. This calendar highlights the deduction weeks in 2019. If your check date falls on a highlighted day within the calendar, a deduction will be taken.

If you are in arrears, a deduction will be taken from a payroll period not highlighted. If a deduction is missed on a scheduled deduction week, future deductions will be taken up to **1.5 times the regular rate** until the balance is paid in full, with the exception of the Healthcare and Dependent Daycare Spending Accounts and 401(K) loans. Missed deductions can occur when an Associate does not receive pay for any reason or does not gross enough money to cover the deduction in full.

Missed deductions for Healthcare and Dependent Daycare Spending Accounts will calculate as follows:

- Your calendar year election minus amount paid (year-to-date).
- The difference will be divided by your remaining payroll checks.
